ORDER FOR CHILD CUSTODY EVALUATION

The Court finds that a child custody evaluation would be of assistance to the Court, the evaluation is in the best interest of the child(ren), and that good cause has been shown for the appointment of an evaluator. Therefore, it is ORDERED that the Harris County Domestic Relations Office is appointed to prepare a child custody evaluation regarding the circumstances and condition of: (1) the child(ren); (2) each party; and (3) the residence of any person requesting conservatorship of, possession of, or access to the child(ren) of this suit. The Court finds that evaluators employed by or under contract with the Harris County Domestic Relations Office are qualified to conduct child custody evaluations pursuant to Section 107.104(b)(3). The evaluation shall follow the requirements contained in Chapter 107, Subchapter D, Texas Family Code.

Each party is ORDERED to sign appropriate releases for the Harris County Domestic Relations Office to review the child(ren)'s and the party's own school records; physical and mental health records; and records from any other collateral source that may have relevant information.
